US-59 Improvements • From Baron to Westville, OK • J/P: 33461(04)

The Oklahoma Department of Transportation (ODOT) will host an in-person Open House to inform the public of the proposed improvements to US-59 from just north of the Shell Branch Creek bridge near Baron, OK and extending north approximately 5 miles to the US-62/US-59 Junction in Westville, OK. At the Open House, the public can ask questions, learn about the proposed construction activities, sequencing, and scheduling, provide input, and submit comments. It will be a come-and-go format with no formal presentation. PROJECT OVERVIEW

Project Limits

From just north of Shell Branch Creek bridge near Baron, OK extend north approximately 5 miles to Westville, OK

Purpose

Improve the safety of US-59 by replacing deteriorating pavement, correcting steep dips & hills, widening narrow shoulders, and facilitating traffic flow

Proposed Improvements

- Widen US-59 to create two-12-foot lanes with 8-ft shoulders
- Add alternating northbound & southbound passing lanes to improve traffic flow
- Realign angled intersections, drives & entrances to be perpendicular
- Correct steep hills & dips to improve sight distances
- Replace and lengthen the Shell Branch Creek tributary bridge to match the 40-foot roadway width
