


# **Parent Partnerships**

## What is OPSR?



 OPSR was created in 2002 by House Bill 1094 to support Oklahoma Families and children from birth to preschool by improving school readiness.

#### How do We This?

- We convene programs and organizations that improve access to health services, high quality early care and learning opportunities and support services for parents and families.
- Through consistent and collaborative planning and decision making, we maximize the use of public and private funding and pursue policies that improve learning opportunities and environments for Oklahoma's children age 5 and under.

### MISSION

Our mission is to lead Oklahoma in coordinating an early childhood system that strengthens families and ensures all children are ready for school

### VISION

Our vision is that all Oklahoma Children are safe, healthy, eager to learn and ready to succeed by the time they enter school.

# **Strengthening Parent Voice**

- Collaborate to include parent voice to help inform the work of Oklahoma's child serving systems to strengthen families
- Parent voice and input is vital in making sure that early childhood is well informed specifically when reviewing potential legislation impacting children 0-8
- OPSR and OCCY collaborate on connecting other agencies and leaders in early childhood
- OPSR utilizes OCCY PPB as its parent partnership board
- OPSR through the Clearinghouse for Early Childhood Success provides funding to OCCY PPB to reduce financial barriers to parents that serve on the Board

# **Parent Leadership Opportunities**



### On the National Level: Birth and Foster Parent Partnership (BFPP)

- Formed in 2016 to support a national movement of birth parents, foster families, kinship caregivers
  and staff focused on building connections and using their collective voices to transform systems,
  culture, policies and practices to improve outcomes for children and families
- Collaboration between the Children's Trust Fund Alliance, Youth Law Center's Quality Parenting Initiative and Casey Family Programs
- Members created two resource tools:
  - Birth and Foster Parent Partnership: A Relationship Building Guide
  - Birth and Foster Parent Partnership: A State and Local Leader's Guide to Building a Strong Policy and Practice Foundation




# **OCCY Technical Assistance & Support**



# On the State Level: OCCY Support for Parent Leadership Programs

- Convene and coordinate public/private partnerships to support parent voice
- Provide technical assistance and training for parent groups and coordinators/professional staff
- Promote and help recruit parents for leadership opportunities – local, state and national
- Provide resources and materials to organizations and communities related to parent engagement
- Role-model and serve as mentor to other parents, advisory groups, and providers

- Start a parent advisory council or board in your community or include parents in already existing councils, boards, etc.
- Include parents in planning and organizing



Address community mental health. Develop and recommend a best practice checklist all child-serving agencies use to ensure there is a focus of trauma-informed care practice.





### The team is unified around the following vision:

Every family lives a safe, prosperous life and has equitable access to individualized supports and services within their community to reach family goals.

#### What has been revealed

The challenges of the public health crisis and the severity of its impact on families involved with the current child welfare system heighten the urgency for change. The inequities in our current system and the disparities it produces are more visible than ever before.

#### What can be done

TFSC is a national initiative led by four national partners. The United States Children's Bureau, Casey Family Programs, the Annie E. Casey Foundation, and Prevent Child Abuse America have joined together with parents, youth, and community organizations in partnership across the public, private, and philanthropic sectors to create a more equitable child and family well-being system that benefits all children and families. With the goal of breaking harmful intergenerational cycles of trauma and poverty.

#### The three areas of focus

Be prevention-focused

Committed to equity for all through the lens of race equity

Be co-designed with people with lived experience

#### What is needed to succeed

It is essential that transformation efforts are led by and with community leaders and community partnerships far outside of the child welfare agency.

The TFSC team will work alongside community members and individuals with lived expertise to provide supports in identifying goals, desired outcomes, and strategies as well as support around implementation that could include funding. You will be provided technical assistance in several areas including creating community-based opportunities.


# Poteau/ LeFlore County

#### **MILESTONE**


Joint action-planning between community coalitions, minority board members, families of the peer-to-peer network, and TFSC/CSAW subcommittees.

We will co-create with system partners to shape a shared understanding of the pathways needed to improve child and family wellbeing communities across Oklahoma.






