**RE: SoonerSelect Dental Program**

Dear Provider,

In January, the Oklahoma Health Care Authority (OHCA) [announced](#) the selection of two dental contracted entities, otherwise known as dental benefit plans (DBPs), to execute the dental component of OHCA's comprehensive delivery system reform, called SoonerSelect. The selected DBPs are DentaQuest and LIBERTY Dental Plan.

DentaQuest and LIBERTY Dental Plan will begin administering the SoonerSelect dental program for most [SoonerCare members](#) on February 1, 2024. Members will begin making their plan selections toward the end of 2023.

OHCA is actively working with DentaQuest and LIBERTY Dental Plan on implementation activities, including the development of adequate networks of dental providers. As the DBPs begin their provider outreach campaigns over the next several months, we encourage you to engage in contracting and credentialing discussions with the plans. Participating in active communication with the plans will ensure that the SoonerCare members you serve have a robust provider network once the SoonerSelect dental program goes live in February 2024.
