RE: Vyvanse® Chewable Tablets, QuilliChew ER®, and Diabetic Testing Supplies Coverage in 2022

Vyvanse® Chewable Tablets and QuilliChew ER®

Effective January 1, 2022, Vyvanse® chewable tablets and QuilliChew ER® will move from Tier-1 to the special prior authorization (PA) tier of the ADHD Medications Tier chart.

- Vyvanse® chewable tablets* and QuilliChew ER® will no longer be preferred, and members currently on these medications will need to switch to either Vyvanse® capsules, a Tier-1 long-acting methylphenidate capsule (i.e., methylphenidate CD or methylphenidate LA), or another available Tier-1 medication, all of which do not require PA. If there is a patient-specific, clinically significant reason the member needs to remain on current therapy with Vyvanse® chewable tablets or QuilliChew ER®, a PA form must be submitted documenting the clinically significant information.
 - *Due to the manufacturer's decision to no longer participate in the state supplemental rebate program.
- If appropriate to switch therapy, current Tier-1 long-acting stimulant medications available without PA and which can be used for members who cannot swallow capsules/tablets include: Daytrana® patches; Vyvanse® capsules which can be opened and dissolved in a glass of water or orange juice or mixed with yogurt; and amphetamine/dextroamphetamine ER, brand Focalin XR®, methylphenidate CD, and methylphenidate LA capsules which can all be opened and sprinkled onto applesauce.
- Special formulations (e.g., Daytrana® patches, Dyanavel® XR, Quillivant XR®, Vyvanse® chewable tablets, QuilliChew ER®) have an age restriction of 10 years of age and younger. In addition to other applicable PA criteria, members older than 10 years of age will require a reason why a special formulation product is needed.

Diabetic Testing Supplies

Effective January 1, 2022, FreeStyle and Precision blood glucose test strips and meters will no longer be a SoonerCare preferred brand. The preferred brands will be OneTouch and True Metrix glucose test strips and meters. SoonerCare will reimburse for once daily testing for members with non-insulin dependent diabetes mellitus (DM) and will reimburse for multiple tests per day for members with insulindependent DM. The FreeStyle Libre and Dexcom continuous glucose monitor (CGM) systems will continue to be SoonerCare preferred brands for CGMs.
