Who We Are

Medicaid gives access to health care for those who qualify. This is determined based on income and/or resources. In Oklahoma, SoonerCare is the name of the Medicaid program, and the Oklahoma Health Care Authority (OHCA) is the state agency that administers it.

SoonerCare works to ensure that medically-necessary benefits and services are available to qualifying Oklahomans. These include certain low-income children, seniors, the disabled, breast or cervical cancer patients, and those seeking family planning services.

Twenty-six percent of Oklahoma lives are covered by OHCA. The OHCA Primer lists additional qualifying groups at www.okhca.org/reports.

The OHCA also operates Insure Oklahoma, which assists qualifying adults and small business employees in obtaining health care coverage for themselves and their families.

What We Cover

There are limits in place to ensure that SoonerCare provides only medically-necessary services and, in some cases, particular benefits are for children only. Many services are required under federal law. The Centers for Medicare & Medicaid (CMS) Services monitor these mandatory benefits.

There is no cost to members who meet the SoonerCare income guidelines; however, copays may apply to some services for adults. The latest SoonerCare income guidelines are available at www.okhca.org/income-guidelines.

- Account for 46 percent of all expenditures

SOONERCARE ENROLLMENT

Most people who qualify for SoonerCare are:

- children younger than age 19;
- pregnant women;
- younger than age 21 and in foster care;
- a former foster care individual aged 18 26 who aged out of the Oklahoma Foster Care program;
- aged 65 and older;
- blind or disabled;
- the parent or relative who is the caretaker of a child;
- · living in a nursing facility;
- in medical need of certain home and community-based services

ONLINE ENROLLMENT

- Provides real-time eligibility decision AND enrollment
- Used for 70 percent of SoonerCare applicants
- Handles 30K 35K applications monthly, with an average of four persons per application
- Verifies information through data exchanges

ACHIEVEMENTS

- First online, real-time Medicaid eligibility and enrollment application
- SoonerCare continues to have one of the best Payment Error Rate Measurements (PERM rates) in the nation
