Subject: **OTC Pediculicides, PA Pharmacy Fax Numbers, SMAC & Soon To Be Sooners**

Please note the following:

### **OTC Pediculicides Now Covered**

OHCA is pleased to announce that OTC treatments for lice are now a covered benefit for all members. A prescription is required for coverage, and fills are limited to one individual package size for a seven day supply. Effective May 1, 2008, prescription products in this category will require prior authorization. Please see below for product-specific authorization criteria.

#### Covered OTC Products (No Authorization Necessary)

- Permethrin 1% shampoo
- Permethrin 1% crème rinse

#### Lindane lotion & shampoo

- Available only after first-line treatment with an OTC product has failed
- Member must be at least 13 years old or weigh at least 110 pounds
- Quantity limit of 60ml for 7 day supply
- One 7 day supply per 30 days maximum

#### Malathion lotion (Ovide<sup>®</sup>)

- Available only after treatment with an OTC product and lindane have failed
- Member must be at least 6 years old
- Lindane trial not required is member is 6 to 13 years old and weighs less than 110 pounds
- Quantity limit of 60ml for 7 day supply; may be repeated once if needed for current infestation after 7 days from original fill date

#### Crotamiton lotion (Eurax<sup>®</sup>)

- Available only after treatment with OTC product has failed
- Quantity limit of 60 grams or milliliters for 30 day supply

### **Prior Authorization Fax Numbers**

A recent “Dear Provider” letter sent to OHCA providers may have created confusion regarding the fax numbers to be used for submitting prior authorization requests. Please note that the fax numbers for submitting Pharmacy requests have not changed, but the fax numbers for submitting Durable Medical Equipment (DME) and other non-pharmacy requests have changed.

### **Requests for Reconsideration of State Maximum Allowable Cost (SMAC) Pricing**

Providers seeking a review of the reimbursement rate for a medication should contact the OHCA Pharmacy Help Desk. Please be prepared to provide the representative with specific claim and drug information, and to fax a copy of a recent invoice for the medication in question. In most cases, the review will be completed within 1 business day after receiving the invoice. Providers will be contacted with the results of the review, and will be informed of any change to the reimbursement rate.

### **New “Soon-To-Be-Sooners” Program Includes Pharmacy Benefit**

OHCA is pleased to announce that pregnancy-related health care services have been expanded for the benefit of babies who will be born as citizens of Oklahoma and the United States. Beginning April 1, 2008, the “Soon-To-Be-Sooners” (STBS) program will be available to provide health care benefits for unborn children. SoonerCare coverage of pregnancy-related medical services will be available for pregnant women who would not otherwise qualify for SoonerCare benefits due to their citizenship status. The STBS program is federally approved.

Prenatal vitamins are covered for STBS members. Additional medically necessary prescriptions may be covered with prior authorization when the medications provide benefit to the unborn child. Please use the universal petition form (OHCA form Pharm-4) for medication prior authorization requests. These requests should include a brief description of the benefit to the unborn child in the section labeled “diagnosis/disease state.” Requests may be faxed to the OU College of Pharmacy at the number listed above. STBS members are subject to the prescription limit of six per month, with a maximum of three brand name drugs per month.
