## Plavix®, Effient ™ Prior Authorization

Effective immediately, Plavix® & Effient™ will not require prior authorization for the first 90 days of therapy per year. (The 90-day PA exemption is based on the 365 days preceding the prescription fill date, not calendar year.) Longer-term therapy continues to require prior authorization. All prior authorizations are approved for duration of 1 year. After the end of 15 months of therapy, prescribers should provide supporting information for the continuation of these products.

#### Plavix® Approval Criteria:

- Recent Stroke
- Recent myocardial infarction
- Established peripheral artery disease
- Acute coronary syndrome (unstable angina/non-Q-wave MI)
- Percutaneous coronary intervention with stent placement
- Transient ischemic attacks (CVA, Stroke)

### **Effient™ Approval Criteria:**

- The approved diagnoses are UA/NSTEMI and STEMI patients who are to be managed with percutaneous coronary intervention (PCI), primary or delayed.
- Effient™ will not be approved for members with the following situations:
  - CABG surgery
  - o Members with a history of TIA or stroke
- Members greater than 75 years of age will generally not be approved without supporting information.
