Billing Diabetic Supplies

Diabetic supplies should be billed to SoonerCare on a CMS 1500 claim form or using the professional claim option at the OHCA secure web site. Claims will process with HCPCS codes, not NDC numbers. For assistance with claims for diabetic supplies, please contact the OHCA call center at (800) 522-0114 or (405) 522-6205, option 1.

In order to bill SoonerCare for diabetic supplies, providers must have a DME contract. If you are not a contracted DME provider and would like to be, please contact OHCA provider enrollment at (800) 522-0114 or (405) 522-6205, option 5.
