# What is the Electronic Health Record (EHR) Incentive Program?

- Provides a financial incentive to Eligible Professionals (EP) and Eligible Hospitals (EH) for the adoption of and "meaningful use" of certified EHR technology.
- Two ways to qualify
  - ▣ Adopt, Implement, Upgrade (AIU), first year only
  - ▣ Meaningful Use
- Apply for incentive 2011 - 2016
  - ▣ Payments through 2021
    - EP – \$63,750
    - EH – \$2 million base amount (adjusted by hospital discharges)
    - 100% Federally Funded

# OHCA's Role

- Administers the Oklahoma EHR Incentive Program
  - Issues EHR Incentive Payments
  - Tracks Meaningful Use (Beginning 2012)
  - Provides Oversight
- 7 dedicated staff members
  - 90/10 HITECH Funding

# What is Meaningful Use?

- The use of a certified EHR:
  - ▣ In a meaningful manner
  - ▣ For electronic exchange of health information
  - ▣ To submit clinical quality and other measures
- Using certified EHR technology in ways that can be measured significantly in quality and in quantity
- Three stages
  - ▣ Stage 1 (2011 – 2012) – sets the baseline for electronic data capture and information sharing
  - ▣ Stages 2 (2014) & 3 – expands on stage 1 baseline and will be further defined in future rule making.

# Stage 1 Meaningful Use

- Eligible Professionals
  - ▣ 25 meaningful use objectives
    - Minimum of 20 objectives
      - 15 required core objectives
      - 5 out of 10 menu set objectives
    - ▣ 6 clinical quality measures
      - 3 required core measures
      - 3 out of 38 clinical quality measures

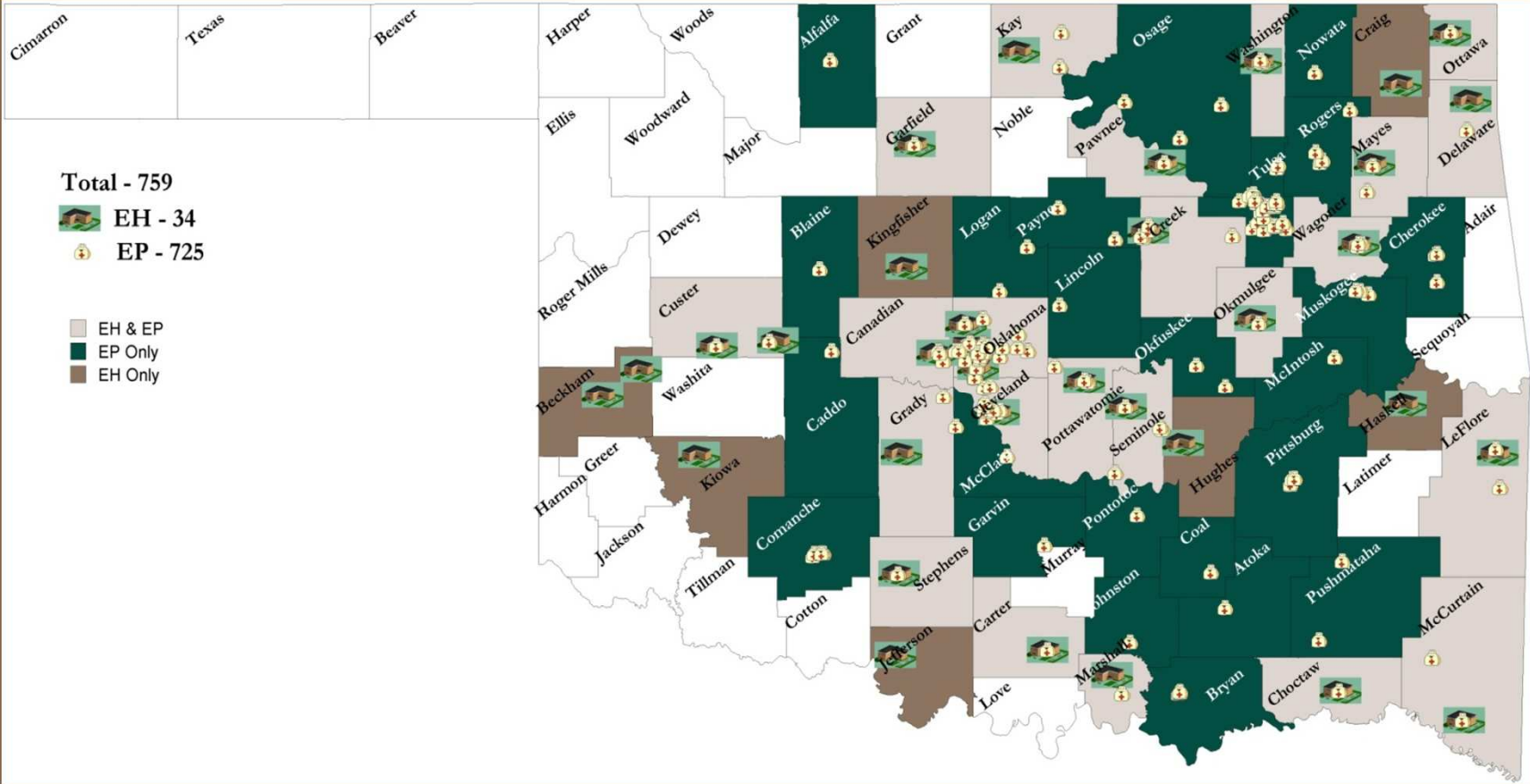
# Stage 1 Meaningful Use cont.

- Eligible Hospitals
  - ▣ 24 meaningful use objectives
    - Minimum of 19 objectives
      - 14 required core objectives
      - 5 out of 10 menu set objectives
    - ▣ 15 clinical quality measures
      - Must report on all measures



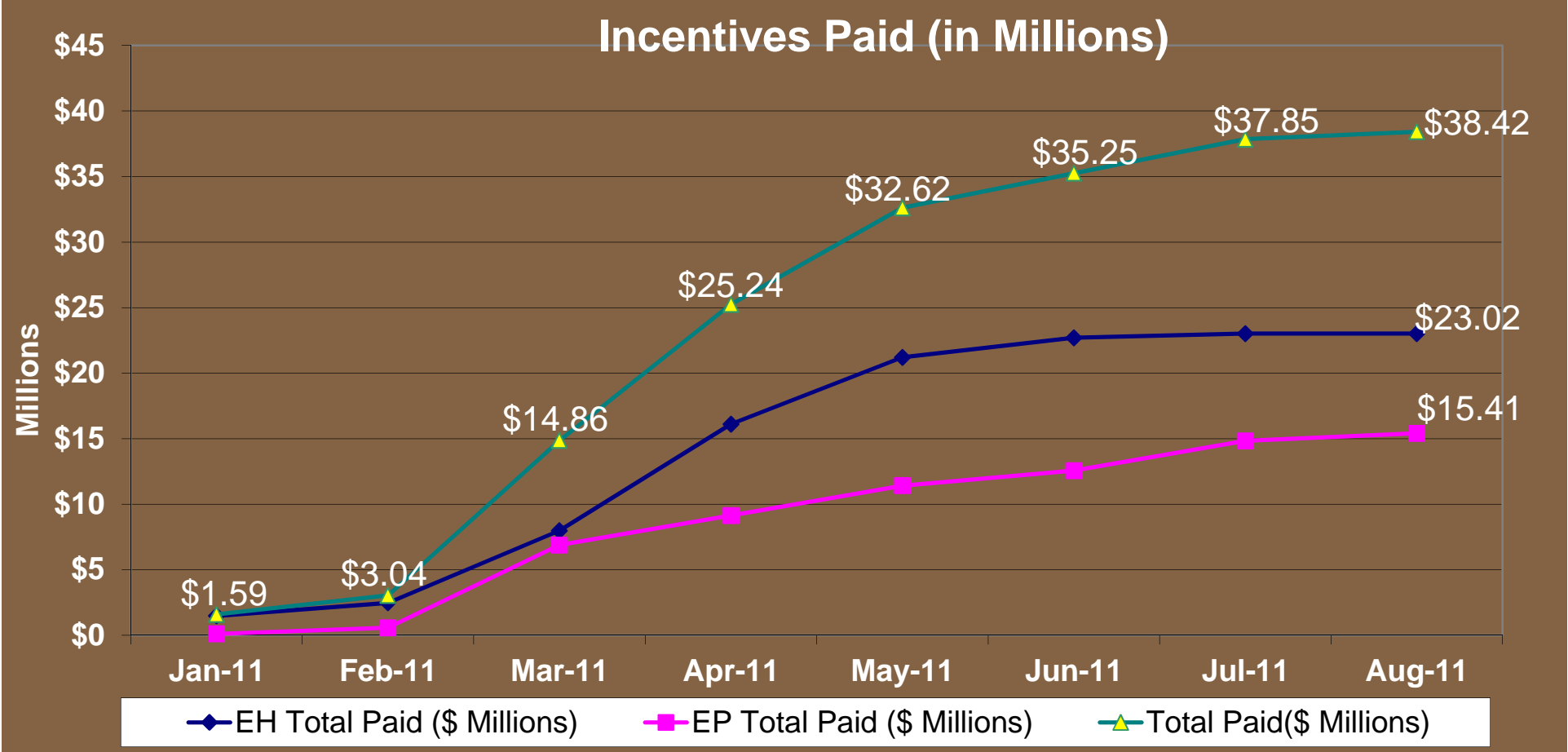
# Total EHR Providers Paid an Incentive Payment
