- Effective January 1, 2005, the State of Oklahoma began providing Medicaid benefits to uninsured women under 65, who are identified through the National Breast and Cervical Cancer Early Detection Program ([NBCCEDP](#)) and are in need of treatment for breast or cervical cancer (including pre-cancerous conditions and early stage cancer).
