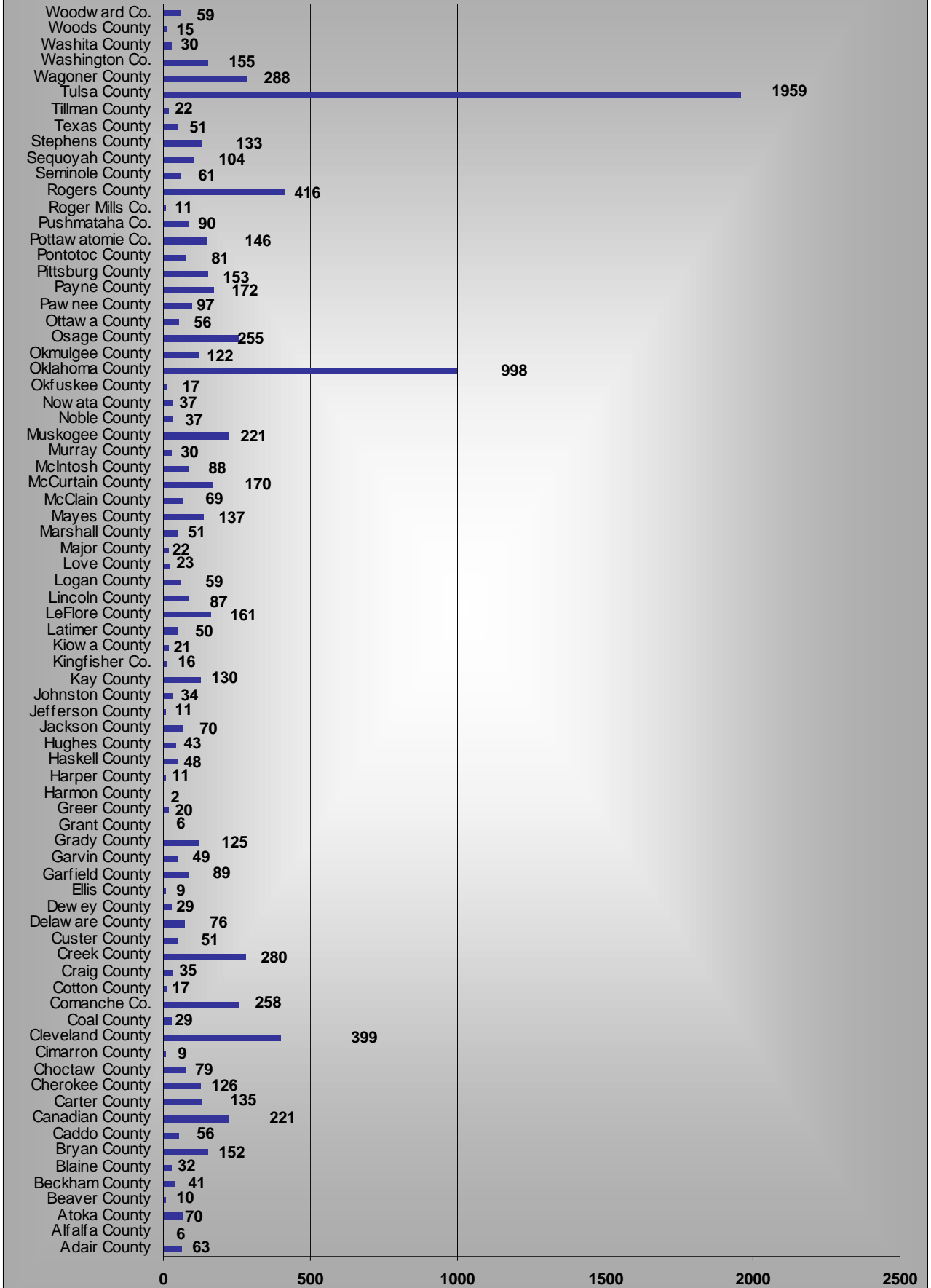

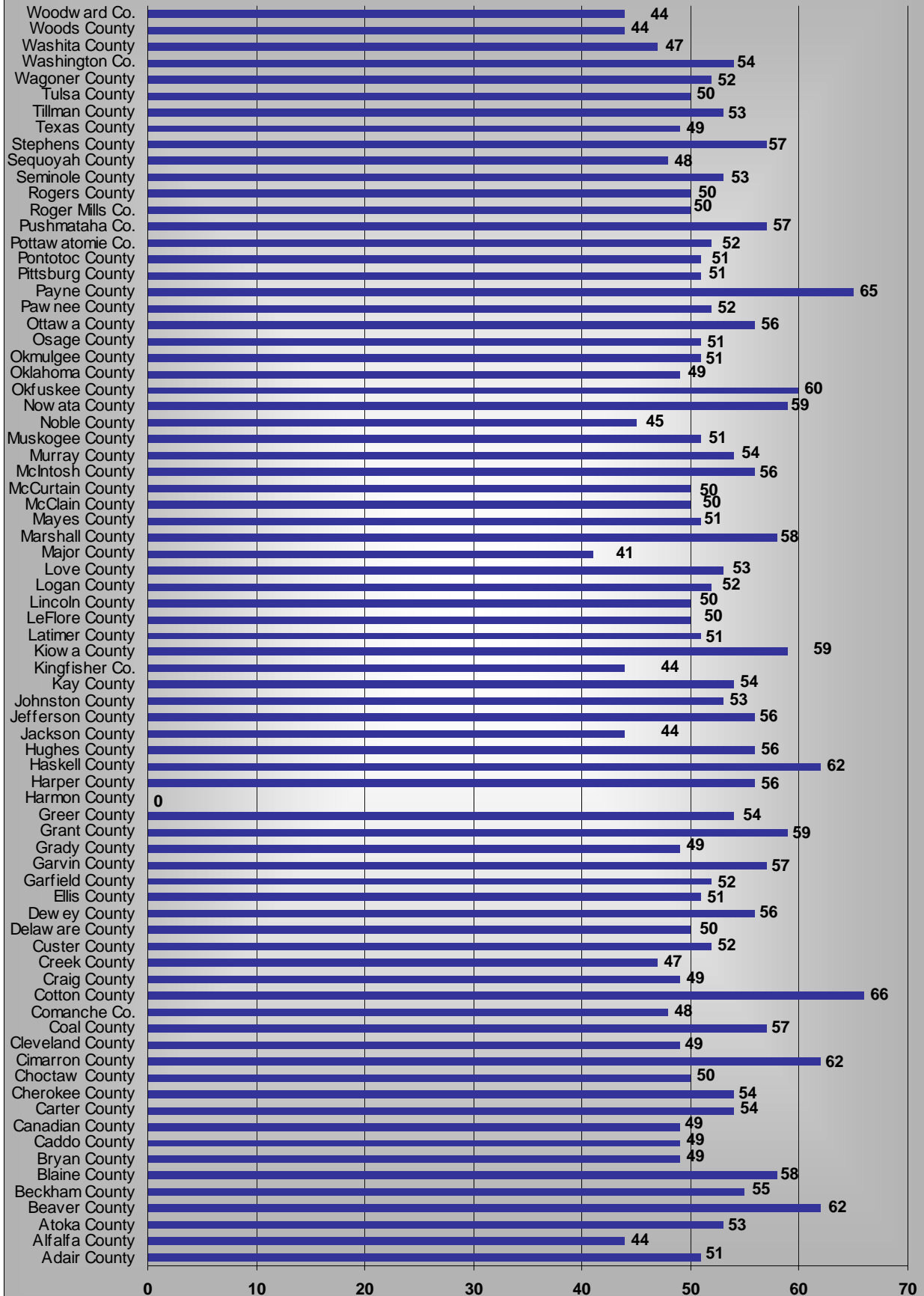

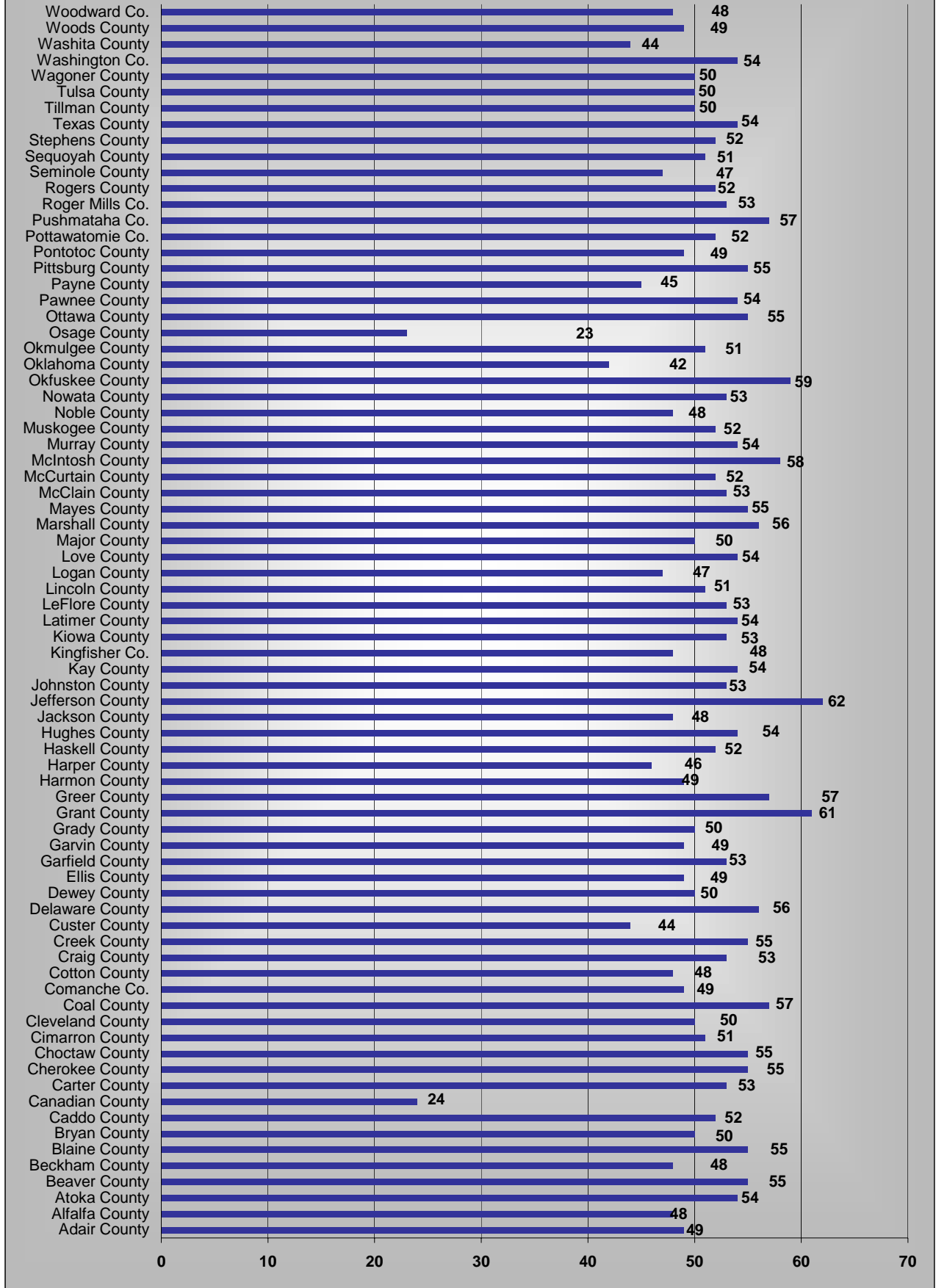
APPROVED BY COUNTY - TOTAL NUMBER



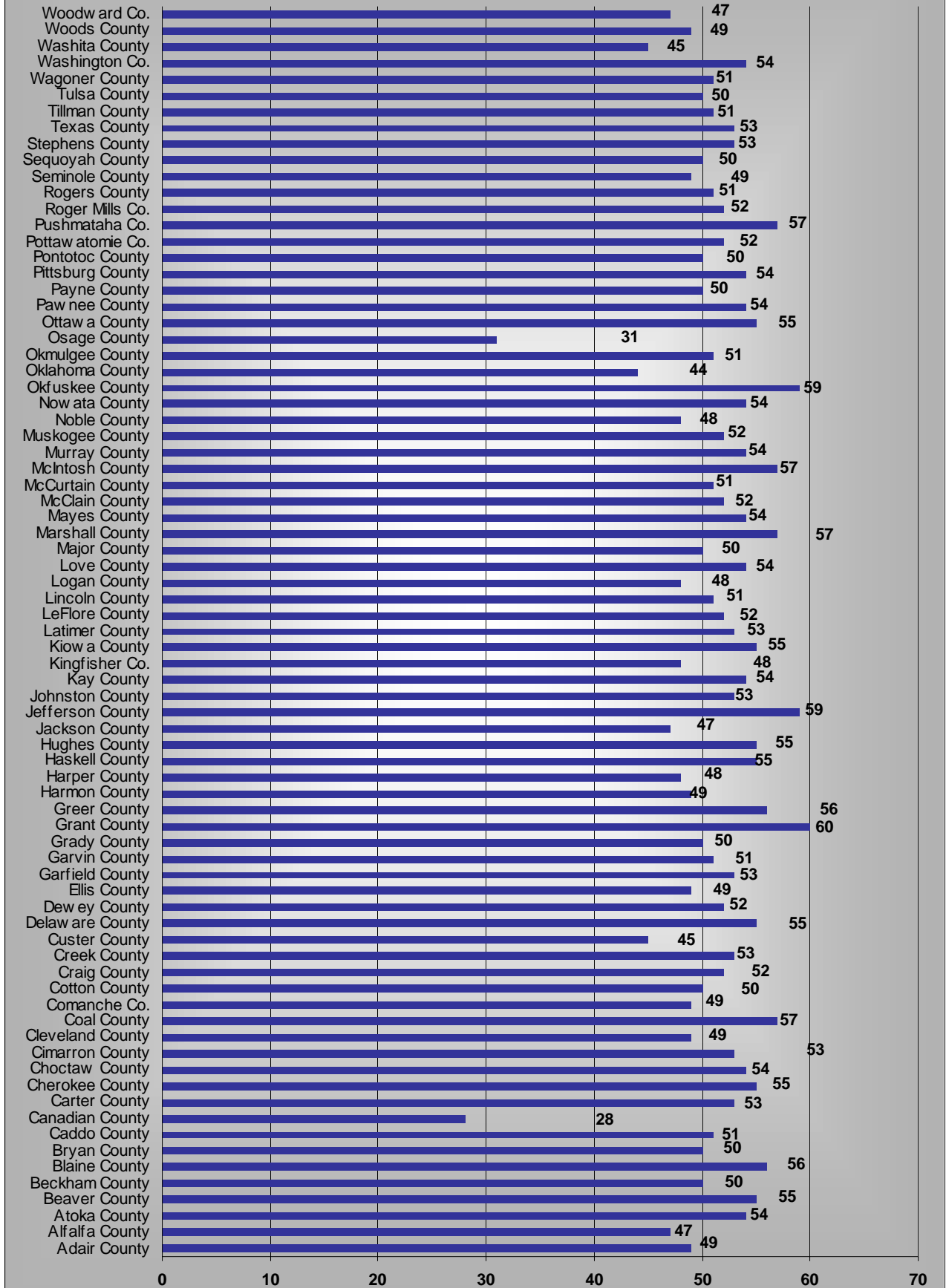
### AVERAGE FEMALE AGE APPROVED BY COUNTY

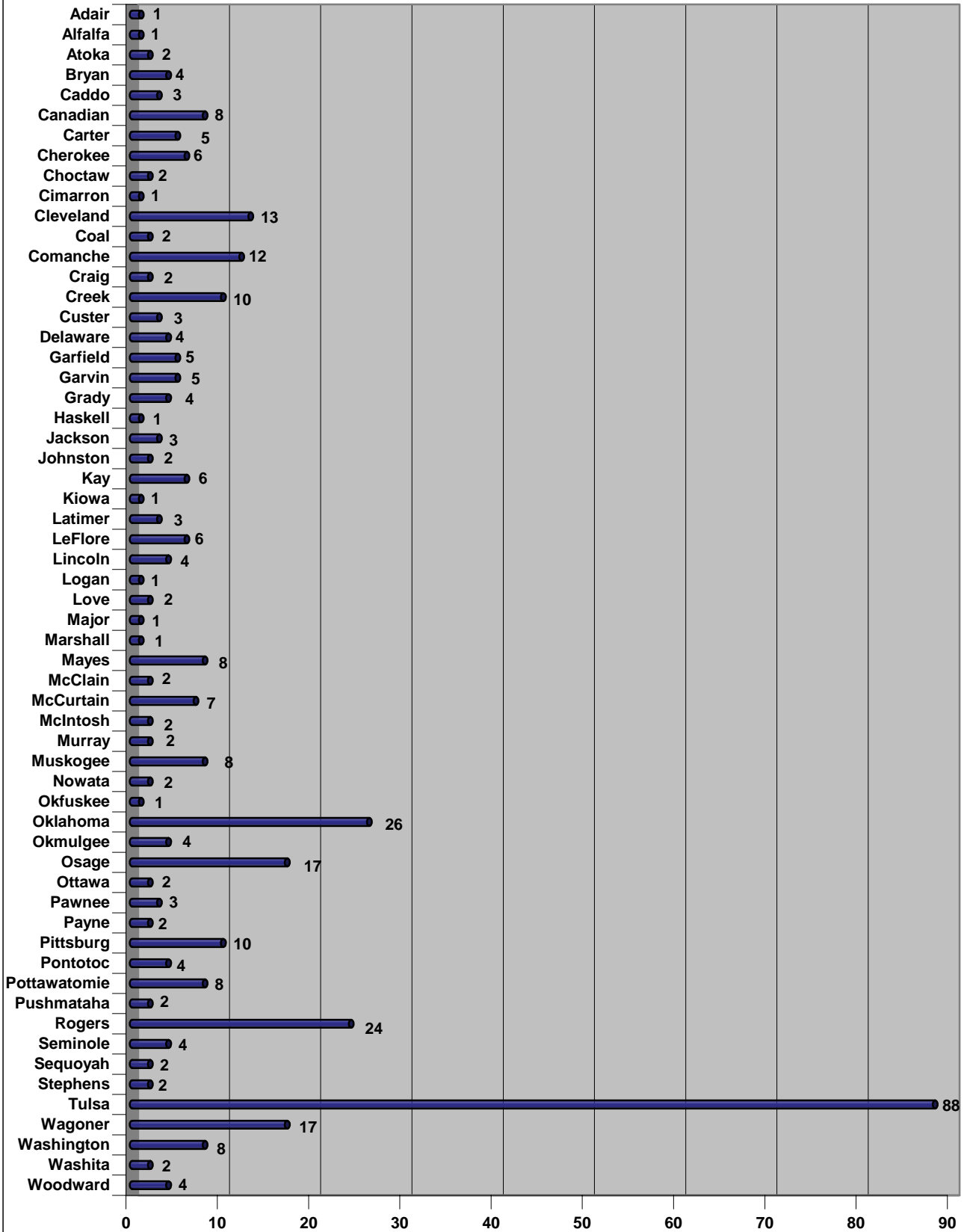

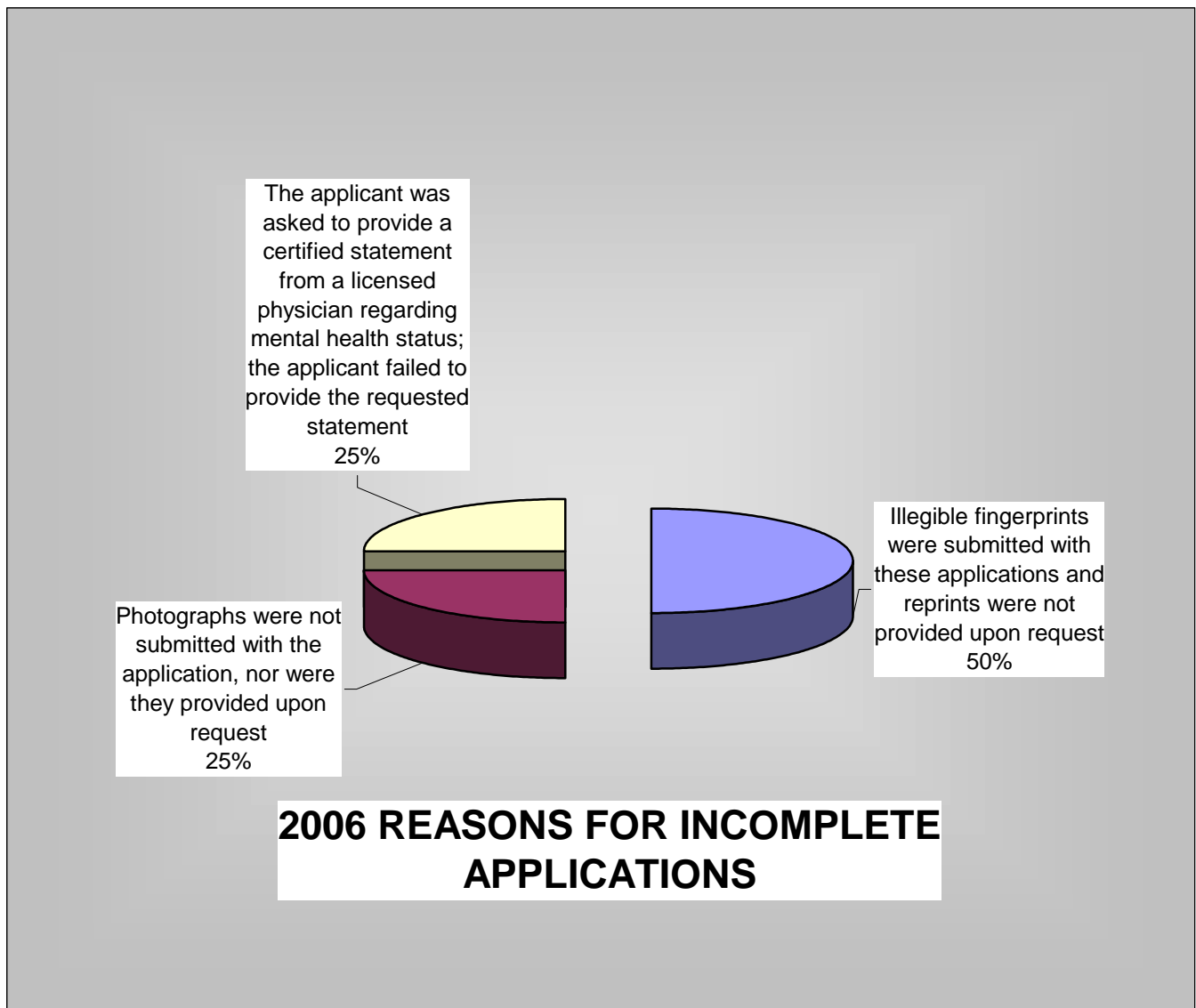

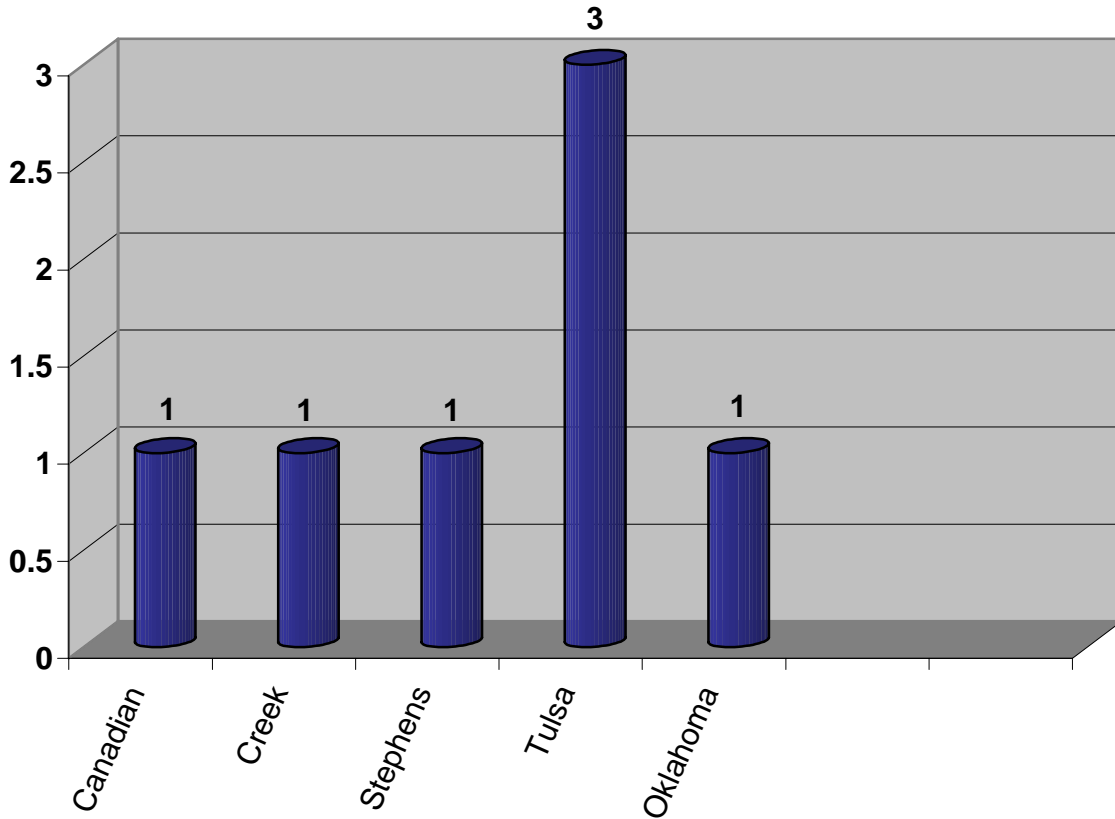
