This is in reference to the Annual report in compliance with 82 O.S. 1020.2(E)(1) for our Troy Quarry (formerly known as " Mill Creek" Quarry) located in Johnston County, OK. Please note that our company's name has changed to Heidelberg Materials Southwest Agg LLC as of January 1, 2023.

Please note that the Groundwater Permit (2008-529) was issued by OWRB on April 28, 2020, and the Stream Water Permit (2008-010) was issued by OWRB on May 26, 2020. Please also note that the Mining Permit (L.E.-2689) was issued by ODOM on July 22, 2019, and became a "producing" mine on October 9, 2019, by physically commencing "permitted extraction from natural deposits". No water was used at the facility in 2023.

Please accept this letter as our Annual Report pursuant to 82 O.S. 1020.2 (E) and 785:30-15 for the calendar year 2023 and hereby report the following:

- (1) Troy Quarry was a producing mine in 2023;
- (2) There is NO Pit Water accumulated or used at the Troy Quarry in 2023;
- (3) Troy Quarry has adopted the Management Plan prior to January 1, 2013, and has implemented the plan upon becoming a "producing" mine. It is our understanding from the consultation meeting on December 27, 2012, that it will maintain the "exempt mine" status for Troy Quarry.
